THE EUROPEAN COMMISSION.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 514/2014 of the European Parliament and of the Council of 16 April 2014 laying down general provisions on the Asylum, Migration and Integration Fund and on the instrument for financial support for police cooperation, preventing and combating crime, and crisis management¹, and in particular Article 14(9) thereof.

Having regard to Regulation (EU) No 516/2014 of the European Parliament and of the Council of 16 April 2014 establishing the Asylum, Migration and Integration Fund, amending Decision 2008/381/EC and repealing Decisions No 573/2007/EC No 575/2007/EC of the European Parliament and of the Council and Council Decision 2007/435/EC², and in particular Article 18(3) thereof,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012³, and in particular Article 110 thereof,

Whereas:

- (1) Commission Decision C(2015)1658 approved the national programme of Slovenia for support from the Asylum, Migration and Integration Fund for the period 2014 to 2020 submitted on 13 March 2015 and set the maximum contribution from the Fund to the national programme of Slovenia.
- (2) On 25 March 2019, Slovenia submitted, through the Commission's electronic data exchange system 'SFC2014', a revised national programme to respond to the shifting migration patterns and subsequent changes in priorities.
- (3) This Decision constitutes a financing decision within the meaning of Article 110 of the Financial Regulation (EU, Euratom) 2018/1046 and a legal commitment within the meaning of point (37) of Article 2 of that Regulation.
- (4) Decision C(2015)1658 should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Articles 1 and 2 of Decision C(2015)1658 are replaced by the following:

"Article 1

The revised national programme of Slovenia for support from the Asylum, Migration and Integration Fund for the period from 1 January 2014 to 31 December 2020, submitted to the Commission in its final version on 25 March 2019, and the recommitments and transfers of amounts set out therein are hereby approved.

Article 2

- 1. The maximum contribution from the Asylum, Migration and Integration Fund to the national programme of Slovenia is set at EUR 20 635 879, and shall be financed from the appropriations entered in the budget line 18 03 01 of the general budget of the Union.
- 2. The maximum contribution shall be composed of the following amounts:
 - (a) a basic amount of EUR 14 725 477 allocated in accordance with Annex I to Regulation (EU) No 516/2014⁴;
 - (b) an additional amount of EUR 600 000 for the Union Resettlement Programme, allocated in accordance with Article 17 of Regulation (EU) No 516/2014;
 - (c) an additional amount of EUR 1 518 000 for the relocation of applicants for international protection from Greece and Italy allocated in accordance with Article 10 of Council Decision (EU) 2015/1523⁵ and Article 10(1)(a) of Council Decision (EU) 2015/1601⁶;
 - (d) an additional amount of EUR 1 600 595 allocated in 2017, in accordance with Annex I to Regulation (EU) No 516/2014;
 - (e) an additional amount of EUR 307 807 allocated in 2018, in accordance with Annex I to Regulation (EU) No 516/2014;
 - (f) an amount of EUR 1 507 200 recommitted or transferred to actions in accordance with the first subparagraph of Article 18(3) of Regulation (EU) No 516/2014;
 - (g) an amount of EUR 376 800 recommitted or transferred to actions in accordance with the second subparagraph of Article 18(3) of Regulation (EU) No 516/2014.".
