#### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 514/2014 of the European Parliament and of the Council of 16 April 2014 laying down general provisions on the Asylum, Migration and Integration Fund and on the instrument for financial support for police cooperation, preventing and combating crime, and crisis management<sup>1</sup>, and in particular Article 14(7) thereof,

Whereas:

- (1) On 23 September 2014, Slovenia submitted, through the Commission's electronic data exchange system (SFC2014), a proposed national programme for support from the Internal Security Fund for the period from 2014 to 2020.
- (2) The policy dialogue with Slovenia referred to in Article 13 of Regulation (EU) No 514/2014 took place on 30 July 2013. The outcome is recorded in agreed minutes dated 24 January 2014.
- (3) The proposed national programme was drawn up by Slovenia with the involvement of the partnership referred to in Article 12 of Regulation (EU) No 514/2014.
- (4) The national programme contains all the elements referred to in Article 14(2) of Regulation (EU) No 514/2014.
- (5) Given the detailed explanation provided by Slovenia in the national programme, it is appropriate to allow Slovenia to depart from the minimum percentage for the allocation of resources set out in point (a) of Article 6(2) of Regulation (EU) No 515/2014 of the European Parliament and of the Council<sup>2</sup> for the objective referred to in point (a) of Article 9(2) of that Regulation.
- (6) Pursuant to Article 14(6) of Regulation (EU) No 514/2014, the Commission made observations on 6 November 2014, 19 February 2015, 16 April 2015, 28 April 2015 and 22 June 2015. Slovenia provided the Commission with all necessary additional information and amended the national programme accordingly. The amended programme was submitted to the Commission on 23 June 2015.

- (7) This Decision constitutes a financing decision within the meaning of Article 84 of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council<sup>3</sup> and a legal commitment within the meaning of Article 85 of that Regulation.
- (8) The amount of the maximum contribution to the national programme of Slovenia from the Internal Security Fund should be indicated, including the breakdown between the basic amount and the additional amount,

HAS ADOPTED THIS DECISION:

#### Article 1

The national programme of Slovenia for support from the Internal Security Fund for the period from 1 January 2014 to 31 December 2020, as submitted in its final version on 23 June 2015, is hereby approved.

#### Article 2

1. The maximum contribution from the Internal Security Fund to the national programme of Slovenia is set at EUR 41 186 180, to be financed from the general budget of the Union as follows:

- (a) budget line 18 02 01 01: EUR 31 304 143
- (b) budget line 18 02 01 02: EUR 9 882 037

2. The maximum contribution from the budget line 18 02 01 01 shall be composed of:

- (a) a basic amount of EUR 30 669 103, allocated in accordance with Annex I to Regulation (EU) No 515/2014;
- (b) an additional amount of EUR 635 040 for the specific action, allocated in accordance with Article 7 of that Regulation.

## Article 3

This Decision is addressed to the Republic of Slovenia.
