Introduction

On 1 January 2020 the Court had 59,676 applications pending before its decision bodies. The purpose of this document is to provide a snapshot of the numbers and types of cases pending against the different Contracting States as at that date. To this end reference is made to the Court's priority policy¹ and the different categories established thereby (I-VII). The countries have been ranked according to the number of pending applications². Their ranking in 2019 is in brackets after the name of the State.

1. The Russian Federation (n°1 in 2019)

There are 15,037 applications pending, of which 14,032 (93%) are in categories I to V and 1,005 (7%) in category VI or VII. 8,579 applications are in the top three categories according to the priority rule. Of the 14,032 applications in categories I to V some groups can be identified: 36% concern conditions of detention; 14% freedom of assembly; 11% other detention issues (like length, lawfulness, family visits in prison); 6% different complaints in some areas of the Donbass region and in Crimea; 3% metal cages in courtrooms; 3% ill-treatment; 3% property issues; 1% events in South Ossetia; 1% operations in North Caucasus.

2. Turkey (n°4 in 2019)

There are 9,236 applications pending, of which 7,946 (86%) are in categories I to V and 1,290 (14%) are in category VI or VII. 4,510 applications are in the top three categories according to the priority rules. Of the 7,946 applications in categories I to V a number of groups can be identified: 62% concern different issues linked to the state of emergency; 12% property issues (such as expropriation, laws on forests or return to villages, failure to pay debts); 6% fairness of proceedings (mainly criminal applications); 4% judicial careers; 2% freedom of expression; 1% ill-treatment.

3. Ukraine (n°3 in 2019)

There are 8,827 applications pending, of which 8,554 (97%) are in categories I to V and 273 (3%) in category VI or VII. 2,010 applications are in the top three categories according to the priority rules. Of the 8,554 applications in categories I to V some groups can be identified: 66% concern different complaints in some areas of the Donbass region and in Crimea; 5% fairness of proceedings; 5% property issues; 3% ill-treatment; 3% the lawfulness of detention; 1% access to court.

4. Romania (n°2 in 2019)

There are 7,879 applications pending, of which 7,724 (98%) are in categories I to V and 155 (2%) are in category VI or VII. 6,732 applications are in the top three categories according to the priority rules. Of the 7,724 applications in categories I to V some groups can be identified: 85% concern conditions of detention; 4% property issues related to restitutions; 3% fairness of proceedings.

5. Italy (n°5 in 2019)

There are 3,071 applications pending, of which 2,945 (96%) are in categories I to V and 126 (4%) in category VI or VII. 327 applications are in the top three categories according to the priority rules. Of the 2,945 applications in categories I to V some groups can be identified: 18% fairness of proceedings; 16% different Italian pensioners' questions; 16% concern length of proceedings and/or non-enforcement of "Pinto" law decisions; 8% other issues linked to the "Pinto" remedy; 6%

preventive measures entailing confiscation of goods linked to the mafia; 5% expropriation; 5% blood transfusions.

6. Azerbaijan (n°6 in 2019)

There are 1,950 applications pending of which as many as 1,926 (99%) are in categories I to V and 24 (1%) are in category VI or VII. 483 applications are in the top three categories according to the priority rules. Of the 1,926 applications in categories I to V, 26% concern refugees from Karabakh and 8% the 4-day border clashes in Karabakh in April 2016, 13% the lawfulness of detention, 12% fairness of proceedings, 6% freedom of assembly; 5%) freedom of association, 4% non-enforcement and 4% freedom of expression.

7. Armenia (n°7 in 2019)

There are 1,631 applications pending, of which 1,545 (95%) are in categories I to V and 86 (5%) are in category VI or VII. 201 applications are in the top three categories according to the priority rules. Of the 1,545 applications in categories I to V, 39% concern refugees from Karabakh, 28% the 4-day border clashes in Karabakh in April 2016 and 5% freedom of assembly.

8. Bosnia and Herzegovina (n°13 in 2019)

There are 1,593 applications pending, of which 1,504 (94%) are in categories I to V and 89 (6%) are in category VI or VII. 2 applications are in the top three categories according to the priority rules. Of the 1,504 applications in categories I to V, 93% concern non-enforcement issues.

9. Serbia (n°9 in 2019)

There are 1,344 applications pending, of which 840 (62%) are in categories I to V and 504 (38%) are in category VI or VII. 39 applications are in the top three categories according to the priority rules. Of the 840 applications in categories I to V, some groups can be identified: 47% concern non-enforcement of judgments rendered against "socially-owned companies"; 10% divergent case-law; 8% length of proceedings; 8% impartiality and independence of the court.

10. Poland (n°10 in 2019)

There are 1,245 applications pending, of which 889 (71%) are in categories I to V and 356 (29%) are in category VI or VII. 111 applications are in the top three categories according to the priority rules. Of the 889 applications in categories I to V some groups can be identified: 30% concern length of proceedings; 15% property issues (taxes, pensions, expropriation, restitution, non-enforcement); 9% access to court; 5% freedom of expression.

11. Republic of Moldova (n°11 in 2019)

There are 1,054 applications pending, of which 1,010 (96%) are in categories I to V and 44 (4%) are in category VI or VII. 209 applications are in the top three categories according to the priority rules. Of the 1,010 applications in categories I to V some groups can be identified: 13% concern fairness of proceedings; 10% ineffectiveness of the remedy concerning non enforcement; 9% property issues (including expropriation); 8% insufficient reasoning of court decisions; 6% conditions of detention; 5% revision of final judgments; 4% different Transdniestrian issues.

12. Greece (n°14 in 2019)

There are 719 applications pending, of which 704 (98%) are in categories I to V and 15 (2%) are in category VI or VII. 296 applications are in the top three categories according to the priority rules. Of

the 704 applications in categories I to V, 30% concern conditions of detention, 13% fairness of proceedings, 12% property issues, 10% access to court and 5% length of proceedings.

13. Albania (n°15 in 2019)

There are 610 applications pending, of which 603 (99%) are in categories I to V and 7 (1%) are in category VI or VII. 24 applications are in the top three categories according to the priority rules. Of the 603 applications in categories I to V, 47% concern property issues related to restitution, 12% concern length of proceedings, 9% non-enforcement, 7% fairness of proceedings and 6% access to court.

14. Georgia (n°8 in 2019)

There are 597 applications pending, of which 557 (93%) are in categories I to V and 40 (7%) are in category VI or VII. 86 applications are in the top three categories according to the priority rules. Of the 557 applications in categories I to V, 78% derive from the events in South Ossetia and 2% in Abkhazia. 20% of the remaining applications concern fairness of proceedings, 17% ill-treatment and 16% various property issues (expropriation, enforcement of judgments).

15. Croatia (n°16 in 2019)

There are 513 applications pending, of which 398 (78%) are in categories I to V and 115 (22%) are in category VI or VII. 106 applications are in the top three categories according to the priority rules. Of the 398 applications in categories I to V, 18% concern fairness of proceedings, 15% property issues, 15% conditions of detention, 15% length of proceedings and 7% access to court.

16. France (n°18 in 2019)

There are 506 applications pending, of which 393 (78%) are in categories I to V and 113 (22%) are in category VI or VII. 104 applications are in the top three categories according to the priority rules. Out of the 393 applications in categories I to V, 13% concern conditions of detention, 12% expulsion or other applications with a Rule 39 request, 8% access to court, 10% freedom of expression, 5% impartiality and independence of the court and 3% lawyers' presence during police custody.

17. Bulgaria (n°17 in 2019)

There are 498 applications pending, of which 448 (90%) are in categories I to V and 50 (10%) are in category VI or VII. 92 applications are in the top three categories according to the priority rules. Of the 448 applications in categories I to V some groups can be identified: 23% concern various property issues (restitution and its effects, enforcement of judgments, expropriation), 10% conditions of detention, 6% prisoners' right to vote, 6% fairness of proceedings, 6% access to court and 6% judicial careers.

18. Hungary (n°12 in 2019)

There are 498 applications pending, of which 377 (76%) are in categories I to V and 121 (24%) are in category VI or VII. 85 applications are in the top three categories according to the priority rules. Of the 377 applications in categories I to V, 36% concern length of proceedings, 11% length of judicial detention, 9% freedom of expression and 7% life imprisonment.

19. North Macedonia (n°19 in 2019)

There are 344 applications pending, of which 309 (90%) are in categories I to V and 35 (10%) are in category VI or VII. 28 applications are in the top three categories according to the priority rules. 50%

of the 309 applications in categories I to V concern property issues, 7% length of proceedings, 6% access to court and 4% discriminations related to Roma.

20. Belgium (n°20 in 2019)

There are 277 applications pending, of which 257 (93%) are in categories I to V and 20 (7%) are in category VI or VII. 93 applications are in the top three categories according to the priority rules. Of the 257 applications in categories I to V, 27% concern psychiatric internment, 15% lawyers' presence during police custody and 14% fairness of proceedings

21. Latvia (n°23 in 2019)

There are 213 applications pending, of which 136 (64%) are in categories I to V and 77 (36%) are categories VI or VII. 12 applications are in the top three categories according to the priority rules. Of the 136 applications in categories I to V, 18% concern property issues, 24% length of proceedings and 7% concern unlawful search.

22. Portugal (n°25 in 2019)

There are 213 applications pending, of which 204 (96%) are in categories I to V and 9 (4%) are in category VI or VII. 86 applications are in the top three categories according to the priority rules. Of the 204 applications in categories I to V, 38% concern conditions of detention, 9% fairness of proceedings, 9% access to court and 6% freedom of expression.

23. Netherlands (n°24 in 2019)

There are 188 applications pending, of which 106 (56%) are in categories I to V and 82 (44%) are in category VI or VII. 44 applications are in the top three categories according to the priority rules. 32% of the 106 applications in categories I to V concern expulsion or the refusal of a residence permit for purposes of family reunion or immigration issues.

24. Germany (n°27 in 2019)

There are 182 applications pending, of which 89 (49%) are in categories I to V and 93 (51%) are in category VI or VII. 2 applications are in the top three categories according to the priority rules. 21% of the 89 applications in categories I to V concern freedom of expression, 18% civil servants penalised for trade union activities and 11% fairness of proceedings.

25. Spain (n°21 in 2019)

There are 162 applications pending, of which 75 (46%) are in categories I to V and 87 (54%) are in category VI or VII. 18 applications are in the top three categories according to the priority rules. Of the 75 applications in categories I to V, 11% concern expulsions, 9% fairness of proceedings and 8% the lawfulness of detention.

26. Lithuania (n°22 in 2019)

There are 148 applications pending, of which 81 (55%) are in categories I to V and 67 (45%) are in category VI or VII. 21 applications are in the top three categories according to the priority rules. Of the 81 applications in categories I to V, 30% concern several property issues including expropriation, destruction and restitution and 11% conditions of detention.

27. Slovakia (n°26 in 2019)

There are 142 applications pending, of which some 114 (80%) are in categories I to V and 28 (20%) are in categories VI or VII. 19 applications are in the top three categories according to the priority rules. Of the 114 applications in categories I to V, 26% concern length of proceedings, 7% fairness of proceedings and 7% access to the Constitutional Court.

28. Switzerland (n°28 in 2019)

There are 135 applications pending, of which 94 (70%) are in categories I to V and 41 (30%) are in category VI or VII. 18 applications are in the top three categories according to the priority rules. Of the 94 applications in categories I to V, 19% concern expulsion, 9% freedom of expression, 9% fairness of proceedings and 9% discrimination in relation to physically disabled people.

29. Czech Republic (n°31 in 2019)

There are 122 applications pending, of which 89 (73%) are in categories I to V and 33 (27%) are in category VI or VII. 9 applications are in the top three categories according to the priority rules. Of the 89 applications in categories I to V, 35% concern Article 8 issues and 11% fairness of proceedings.

30. United Kingdom (n°29 in 2019)

There are 109 applications pending, of which 75 (69%) are in categories I to V and 34 (31%) are in category VI or VII. 14 applications are in the top three categories according to the priority rules. Of the 75 applications in categories I to V, 17% concern phone tapping, 15% fairness of proceedings and 13% personal data saved in official files.

31. Montenegro (n°30 in 2019)

There are 98 applications pending, of which 36 (37%) are in categories I to V and 62 (63%) are in category VI or VII. 6 applications are in the top three categories according to the priority rules. Of the 36 applications in categories I to V, 50% concern length of civil proceedings.

32. Iceland (n°37 in 2019)

There are 71 applications pending, of which 67 (94%) are in categories I to V and 4 (6%) are in category VI or VII. 4 applications are in the top three categories according to the priority rules. 40% of the applications in categories II to V concern fairness of criminal proceedings.

33. Slovenia (n°32 in 2019)

There are 68 applications pending, of which 38 (56%) are in categories I to V and 30 (44%) are in category VI or VII. 4 applications are in the top three categories according to the priority rules. Of the 38 applications in categories I to V, 55% concern the cancellation of bonds or shares by the Bank of Slovenia.

34. Austria (n°34 in 2019)

There are 67 applications pending, of which 49 (73%) are in categories I to V and 18 (27%) are in category VI or VII. 4 applications are in the top three categories according to the priority rules. Of the 49 applications in categories I to V, 35% concern fairness of proceedings and 12% length of proceedings.

35. Cyprus (n°35 in 2019)

There are 53 applications pending, of which 48 (91%) are in categories I to V and 5 (9%) are in category VI or VII. 8 applications are in the top three categories according to the priority rules. Of the 48 applications in categories I to V, 19% concern fairness of criminal proceedings.

36. Sweden (n°39 in 2019)

There are 53 applications pending, of which 19 (36%) are in categories I to V and 34 (64%) in category VI or VII. 7 applications are in the top three categories according to the priority rules. Of the 19 applications in categories I to V, 42% concern Article 8 complaints and 37% concern expulsion issues.

37. Norway (n°38 in 2019)

There are 47 applications pending, of which 35 (74%) are in categories I to V and 12 (26%) are in category VI or VII. 4 applications are in the top three categories according to the priority rules. Of the 35 applications in categories I to V, 80% concern child care.

38. Estonia (n°33 in 2019)

There are 43 applications pending, of which 36 (84%) are in categories I to V and 7 (16%) are in category VI or VII. 20 applications are in the top three categories according to the priority rules. 33% of the 36 applications in categories I to V concern conditions of detention.

39. Malta (n°36 in 2019)

There are 40 applications pending, all in categories I to V. Of the 40 applications in categories I to V, 65% concern rent control.

40. Ireland (n°40 in 2019)

There are 23 applications pending, of which 17 (74%) are in categories I to V and 6 (26%) are in category VI or VII. Of the 17 applications in categories I to V, 59% concern women who complain they were subjected to symphysiotomy when they gave birth in Ireland (art. 3, 8 and 13).

41. Denmark (n°42 in 2019)

There are 21 applications pending, of which 11 (52%) are in categories I to V and 10 (48%) are in category VI or VII.

42. Finland (n°41 in 2019).

There are 18 applications pending, of which 11 (61%) are in categories I to V and 7 (39%) are in category VI or VII.

43. Luxembourg (n°44 in 2019)

There are 10 applications pending, of which 8 (80%) are in categories I to V and 2 (20%) in category VII.

44. Monaco (n°45 in 2019)

There are 10 applications pending, of which 7 (70%) are in categories I to V and 3 (30%) are in category VII.

45. San Marino (n°43 in 2019)

There are 9 applications pending in categories IV to V, mainly concerning fairness of criminal proceedings.

46. Andorra (n°46 in 2019)

There is 1 application pending in category IV.

47. Liechtenstein (n°47 in 2019)

There is 1 application pending against Liechtenstein in category IV.
