C: Sredstva in metode identifikacije ovc in koz

1. Načini označitve za drobnico, ki je namenjena za premik v druge države članice:
 - ušesna znamka in elektronska ušesna znamka,
 - ušesna znamka in bolus,
 - izjema za živali z ušesi, premajhnimi za namestitev običajne ušesne znamke: biceljni trak in bolus.
2. Načini označitve za drobnico, ki se goji samo v Sloveniji in ni namenjena za premik v druge države članice:
 - dve ušesni znamki,
 - ušesna znamka in elektronska ušesna znamka
 - ušesna znamka in bolus
 - ušesna znamka in biceljni trak,
 - ušesna znamka in tetoviranje,
 - izjema za živali z ušesi, premajhnimi za namestitev običajne ušesne znamke: dva biceljna trakova.
3. Izjema za živali, ki so namenjene za prevoz neposredno v klavnico pred starostjo 12 mesecev:
 - okrogla ušesna znamka s skupinsko številko (SIŠ),
 - običajna ušesna znamka (ID),
 - biceljni trak (ID).

C: Means and methods of identification for ovine and caprine animals

1. *Methods of identification for animals intended for movement to other MSs:*
 - conventional ear tag and electronic ear tag,
 - conventional ear tag and bolus,
 - exception for animals with ears too small to accommodate a conventional ear tag: conventional pastern band and bolus.
2. *Methods of identification for animals kept in Slovenia not intended for movement to other MSs:*
 - two conventional ear tags,
 - conventional ear tag and electronic ear tag,
 - conventional ear tag and bolus,
 - conventional ear tag and conventional pastern band,
 - conventional ear tag and tattoo,
 - exception for animals with ears too small to accommodate a conventional ear tag: two conventional pastern bands.
3. *Exception for animals intended for movement directly to the slaughterhouse before the age of 12 months:*
 - round ear tag with ID of birth establishment (SIŠ),
 - conventional ear tag (ID),
 - conventional pastern band (ID).

D. Format of the movement document for ovine and caprine animals

Elektronski spremni list za drobnico (e-SLD)

Kadar izvajalec dejavnosti poskrbi, da so podatki o premiku oziroma o odhodu drobnice vpisani v CRD (Centralni register drobnice), se živali lahko premikajo z e-SLD, kar se ustrezno označi v CRD. V tem primeru ni potrebno izpolniti papirnega spremnega lista (SLD).

Papirni spremni list za drobnico (SLD) je sestavljen iz štirih delov:

- izvirnik SLD (sive barve),
- kopija PRIHOD (rdeče barve),
- kopija ODHOD (zelene barve),
- kopija za oddajatelja (bele barve).

Electronic movement document for small ruminants (e-SLD)

When the operator ensures that the movement or departure data are entered in the CDB (Central Database), animals may be moved with an Electronic Movement Document (e-SLD), what shall be indicated in the CDB. In this case, it is not necessary to fill in a paper movement document (SLD).

The paper movement document (SLD) consists of four parts:

- original SLD (grey),
- copy of ARRIVAL (red),
- copy of DEPARTURE (green),
- copy for the sender (white).

The diagram illustrates the layout of the paper movement document (SLD) forms. It consists of four overlapping forms:

- KOPIJA ZA ODDAJATELJA (White):** A copy for the sender, containing fields for identification number, date, and contact information (G-MID, name, address, postal code).
- ODHOD (Green):** A departure form, containing fields for identification number, date, and contact information (G-MID, name, address, postal code).
- PRIHOD (Red):** An arrival form, containing fields for identification number, date, and contact information (G-MID, name, address, postal code).
- SPREMNI LIST ZA DROBNICO (Grey):** The main movement document, containing fields for identification number, date, and contact information for both the sender and the receiver (G-MID, name, address, postal code).

Each form also includes a field for the movement document number (Številka spremnega lista).
