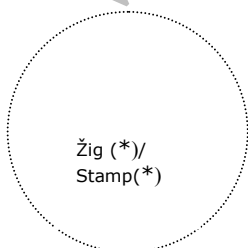

Podpisani uradni veterinar potrjujem, da :/ I, the undersigned official veterinarien declare that:

1. je proizvodni obrat pod uradnim nadzorom, / the production plants are under official control,
2. se proizvodni obrat nahaja v regiji prosti slinavke in parkljavke, / the production plants and the region where the plant is located are free from foot and mouth disease,
3. je proizvod slovenskega izvora in je vzorčen, transportiran, toplotno obdelan in skladiščen v območjih, prostih BSE in živalskih kužnih boleznih, obvezno prijavljivih po bivši listi A O.I.E. Slovenija je država, kjer se izvaja cepljenje proti bolezni Newcastle. Zadnji primer bolezni Newcastle je bil prijavljen pred šestnajstimi (16) leti. V skladu z uradnimi podatki je Slovenija prosta bolezni Newcastle, / The product is of Slovenian origin and sampled, transported, heated and stored in areas which are free of BSE and free of contagious diseases as noticed in range A of the O.I.E. notification. Slovenia is Newcastle's disease vaccination area. The last known case of Newcastle's disease was sixteen (16) years ago. According official knowledge Slovenia is Newcastle's disease free,
4. vse sestavine živalskega izvora (razen mleka in mlečnih proizvodov) izvirajo od živali, ki so bile ante - in post - mortem veterinarsko pregledane ob zakolu in za katere se je ugotovilo, da so proste kužnih bolezni živali in je njihovo meso primerno za prehrano ljudi, / all animal derived material (other than dairy product) was derived from animals which were subjected to ante- and post-mortem veterinary inspection and were found to be free from contagious and infectious disease, the meat of which was passed fit for human consumption,
5. proizvodi, razen mleka in mlečnih izdelkov, ne vsebujejo sestavin govejega izvora, / the product does not contain any bovine derived material other than dairy products,

8. je bil proizvod proizveden in skladiščen v obratu odobrenem od pristojnega organa v skladu z 18. in, kjer je to primerno, z 11. členom Uredbe (ES) 1774/2002, / the products have been produced and stored in a plant approved by a competent authority in accordance with Article 18 and, where appropriate, Article 11 of Regulation (EC) 1774/2002,
9. je mleko v prahu, uporabljeno v proizvodu, pridobljeno od živali prostih slinavke in parkljavke in v njihovi okolici niso veljali restriktivni ukrepi za to bolezen, / the milk powder used in the product(s) was obtained from animals that were free from Foot and Mouth Disease and where no animal health restrictions were in force in their surrounding area due to foot and mouth restrictions,
