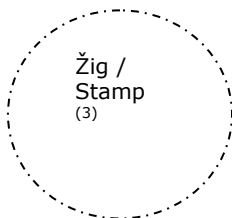

- soljene 7 dni z morskó soljo z dodatkom natrijevega karbonata do 2% / salted for 7 days in sea salt with addition of sodium carbonate to 2 % ⁽¹⁾, ali / or
 - soljene z morskó soljo z dodatkom natrijevega karbonata do 2% dne in v skladu z deklaracijo prevoznika, bodo transportirane z ladjo, prevoz pa bo trajal toliko časa, da bo soljenje zagotovljeno najmanj 7 dni, preden bodo prispele na mejno kontrolno točko / salted in sea salt with addition of sodium carbonate to 2 % on the following date and, according to the declaration of the transporter, the hides and skins will be transported by ship and the duration of transport will be such that they will have undergone a minimum of 7 days salting before they reach the border inspection post ⁽¹⁾, ali / or
 - sušene 42 dni pri temperaturi najmanj 20°C / dried for 42 days at a temperature of at least 20 °C ⁽¹⁾;
