PEST STATUS OF THE LIST OF QUARANTINE ORGANISMS OF THE RUSSIAN FEDERATION FOR POTATOES

Phytosanitary guarantees provided for the export of seed potatoes to the Russian Federation

Official certification of seed potato fields and crops produced by registered producers guarantees at least place of production freedom or unit of production freedom for EU regulated organisms. These are checked by visual inspections, followed by sampling and testing, where appropriate. All other harmful organisms are certified before export based on the pest status in Slovenia.
