The minimum bid price is 18,000 USD.

Bidding process

Written bids for the vehicle can be submitted by post to the Embassy of the Republic of Slovenia in Buenos Aires, at Esmeralda 910, 3rd floor, 1007 Buenos Aires. The envelope must contain the following subject "OFFICIAL VEHICLE SALE". Bids can also be sent by e-mail to sloembassy.buenosaires@gov.si.

The deadline for submitting bids is 20 days from the date of publication on the Embassy's website. Bids submitted by post or received by the Embassy by e-mail will be considered no later than midnight on the last day of the bid submission deadline.

In the offer, the bidder must state his/her details (name, address), contact details, bid price and a statement that the bid will be binding for at least 30 days.

Conclusion of the contract

The vehicle will be sold to the buyer who offers the highest price. The Embassy will negotiate the price and any other conditions directly with the interested parties. The Embassy will conclude a direct sales contract with the selected buyer.

The buyer is obliged to pay the entire purchase price in a lump sum within 8 days of signing the contract. Payment of the purchase price within the specified period is an essential component of the contract. All expenses related to the sale of the vehicle, as well as the expenses related to the repair of the vehicle prior to its sale, will be borne by the buyer.

The Embassy will transfer and deliver the vehicle after payment of the entire purchase price, and the buyer is obliged to take possession of it within 5 days after the payment of the entire purchase price, at the address of the Embassy in Buenos Aires, at Esmeralda 910, 3rd floor 1007 Buenos Aires.

The Embassy may suspend this procedure until the conclusion of the sales contract.
