Skladno s 1. in 2 odstavkom 5. točke 5. člena Zakona o prijavi prebivališča (Ur. l. RS 52/16, 36/21 in 3/22 – ZDeb) soglasje drugega starša ni potrebno, če je otrokov naslov enak naslovu obeh staršev.

Soglasje drugega od staršev ni potrebno, če se otroku prijavlja naslov v tujini, pa je drugi od staršev tujec, ki nima prijavljenega prebivališča v Republiki Sloveniji.

According to Article 5, item 5, paragraphs 1 and 2, of the Residence Registration Act (Official Gazette of the Republic of Slovenia No. 52/16, 36/21 in 3/22 – ZDeb) the consent of the other parent is not required if the minor's place of residence is the same as that of both parents.

If the parents do not live at the same address, the other parent may give their consent by signing this form. Alternatively, the applicant may enclose any of the following documents:

- *Consent of the other parent*
- *Decision on the minor being entrusted to the applicant for care and education*
- *Agreement on the protection, education and maintenance of children*
- *Decision issued by a competent court*
- *Other documents (list the attachment)*

The consent of the other parent is not required when the minor's other parent is a foreigner who does not have a registered residence in Slovenia.
